## The Structure of the PhD Program

The PhD program at the CMU School of Public Policy offers two degree plans, which differ in the requirement to complete coursework and the number of credits for PhD thesis. The curriculum is designed to train new policy scholars in cutting-edge techniques for policy analysis. Methods include dynamic systems modeling, content analysis using software, network analysis, large-scale online surveys, and various quasi-experimental approaches. Conceptual frameworks include policy systems, policy narratives, institutional analysis, social-ecological systems, communication and behavioral psychology, complexity theory, and deliberative democracy.

The **mandatory 48 credits** include the following;

- For Plan 1 (PhD Type 1.1 Thesis only): The student is required to complete only the PhD Thesis worth a total of 48 credits as a requirement for graduation.
- For Plan 2 (PhD Type 2.1 Coursework + Thesis): During the first year the student is required to take 4 compulsory courses for a total of 12 credits. The minimum number of credits earned in the first academic year is twelve. From the second year onward, the student is required to complete the PhD Thesis worth additional 36 credits as a requirement for graduation.

### PhD Candidacy

Students in the first year of the Doctoral Program are referred to as ‘Doctoral Students’. After successfully completing the compulsory coursework (for Plan 2) and qualifying exam(s) but before submitting their PhD thesis they are referred to as ‘Doctoral Candidates’. The PhD thesis should be submitted for evaluation and defense within 3 years after the doctoral students passed the qualifying exam(s), with additional 2-year maximum grace period.

### Supervision

At the beginning of the first year, regular consultations between the Doctoral Students and his/her supervisor, as well as a series of meetings between faculty members at large and doctoral students will help each student to compile a study plan. The Doctoral Supervisory Panel will be set up at the beginning of the program. The panel will assist the student in the choice of the main supervisor. Taking into account the research topic and the candidate’s indication, and based on faculty availability, the Doctoral Committee shall appoint a permanent supervisor to a Doctoral Student before the end of the second semester of the first year. The main supervisor is responsible for communicating with his or her supervisee on an ongoing basis.

## **The Qualifying Examination**

Plan 1 (Thesis-only Track): Doctoral students are required to take a qualifying examination at the beginning of the second semester of the first year, followed by the oral defense of the Thesis Proposal. The examination is scheduled in November - December (exact date to be confirmed). In order to be admitted to the thesis development of the program, you will have to earn a "C" grade or higher at the qualifying examination (at least GPA 2.00 from a 4-scale system). The admission to the program as a Doctoral Student is no guarantee that you advance to Doctoral Candidate status.

Plan 2 (Coursework + Thesis) : Towards the end of the first year, Doctoral students are required to take a qualifying examination, followed by the oral defense of the Thesis Proposal . In order to be admitted to the second year of the program, you will have to earn a "C" grade or higher at the qualifying examination (at least GPA 2.00 from a 4-scale system). Admission to the program as a Doctoral Student is no guarantee to Doctoral Candidate status.

## **The Research Proposal**

Students will be required to submit their research proposal and can defend their proposal before the defense committee. The Thesis Proposal should include arguments about the feasibility of the proposed research, the coherence and suitability of the theoretical, methodological and empirical (if any) components of the thesis, and an assessment of the contribution that the thesis will make to the field. The student shall work closely with his/her Supervisory Panel throughout the process.

## **Research Seminars**

Above the regular course work students must attend research seminars, usually organized by one of the Departments/Faculty at Chiang Mai University, by the School, by the research centers affiliated with the School, or by the voluntary student-faculty workshops, spanning across the academic years. All doctoral students are expected to present at the research seminars at least twice before submitting their PhD thesis for defense.

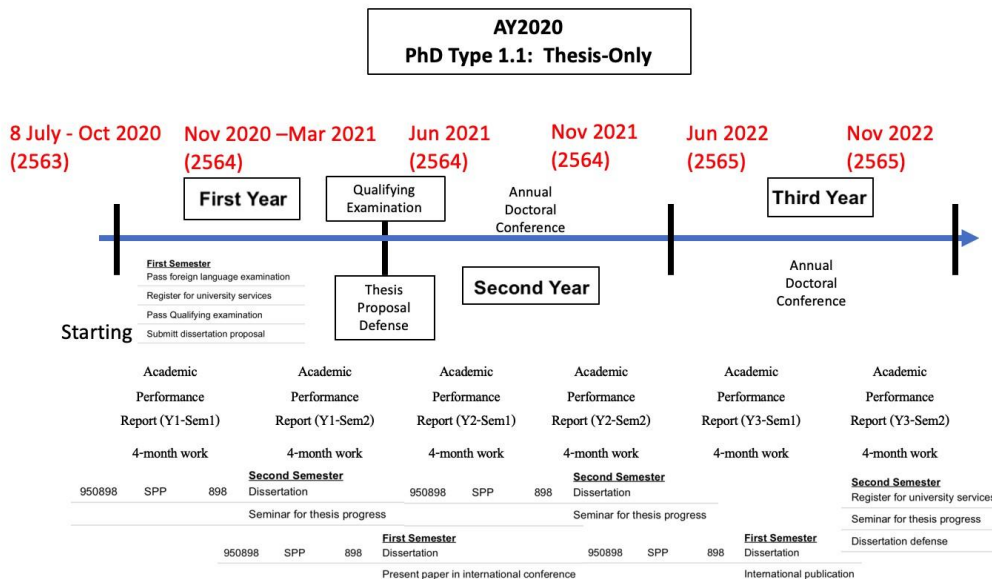
## **Annual Doctoral Conference**

Participation at the Annual Doctoral Conference is mandatory only for doctoral students who have assessed the qualifying examination, but first-year students may also present at the conference.

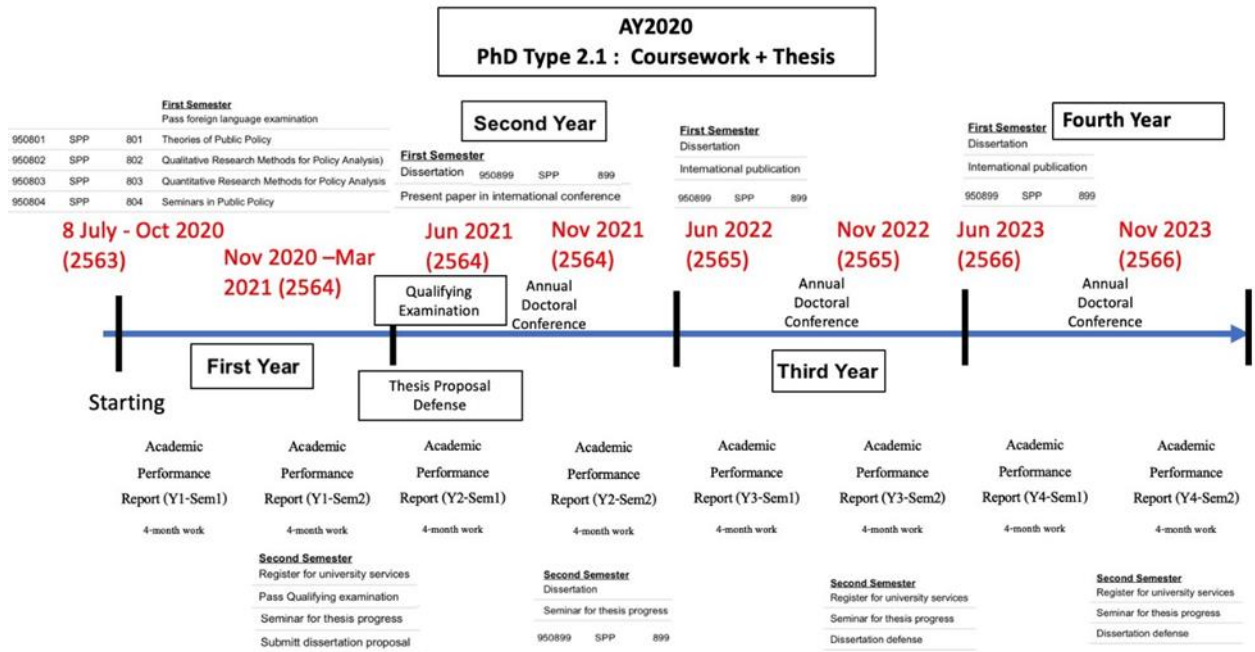
**Plan 1 (Thesis only):**

- Mandatory 48 credits
  - 950898 Dissertation 48 credits
- Academic Activities
  - Annual Doctoral Conference
  - Publication of the PhD Dissertation in accordance with the general regulations of Chiang Mai University
  - Written reports on the student's academic performance, approved by the Curriculum Committee and submitted to the Graduate College every semester in accordance with the general regulations of the University.
- Qualifying Examination
  - Doctoral student must complete an initial probation period at the start of their research degree. You will be required to complete a probation review in the form of examination to determine their qualification prior to submitting the written Research Proposal.
  - Should the Doctoral students fail the qualifying examination, they have one more chance to re-take the examination. However, they must submit the request to re-take the examination within one semester from the last examination date.
  - If the Doctoral Students fail to complete a probation review, the curriculum committee may consider transferring them to a Master-level program.

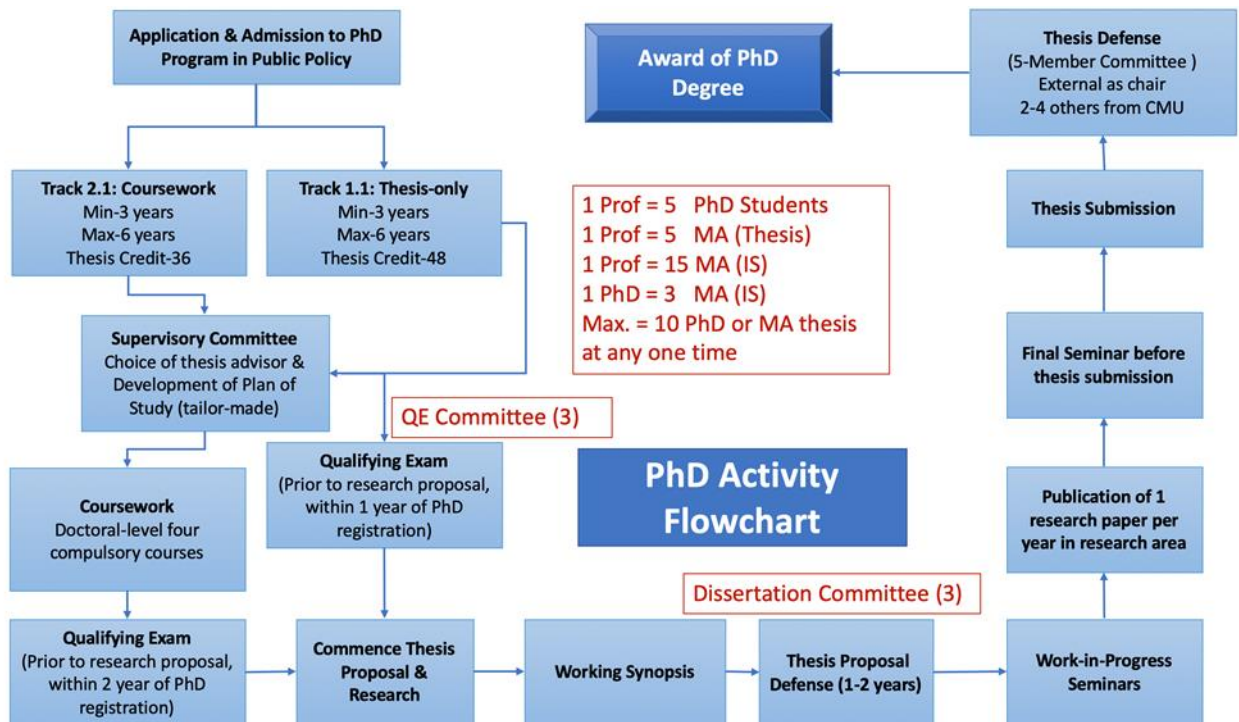

- Qualifying Examination
  - Doctoral students must complete an initial probation period at the start of their research degree. You will be required to complete a probation review in the form of examination to determine their qualification after completing all coursework and prior to submitting the written Research Proposal.
  - Should the Doctoral students fail the qualifying examination, they have one more chance to re-take the examination. However, they must submit the request to re-take the examination within one semester from the last examination date.
  - If the Doctoral Students fail to complete a probation review, the curriculum committee may consider transferring them to a Master-level program.

**Requirement for Graduation according to CMU Regulation on Graduate Education 2559 B.E.**

At the final semester that the student is going to fulfill all courses and conditions specified in the curriculum, the student must report him/her self to the registration office for graduation expectation, endorsed by general advisor or thesis major advisor, then also report to the affiliated academic sector.

Student who is nominated for graduation a degree or diploma must fulfill all the following conditions

1. Having studied courses and fulfilled all the conditions specified in the curriculum.
2. Having received grade point average of all courses at least 3.00 and grade point average of courses in specific field at least 3.00, except program with dissertation or master's thesis only.
3. Having passed a foreign language conditions by examination or any other methods specified by the graduate school
4. Having passed thesis evaluation examination. The dissertation (doctoral program) must be composed in English language or any other language approved by the graduate school, as the individual case may be.
5. Thesis result must be presented in the international academic conference accepted by the field of study with the approval of the graduate school at least once (*Applicable only for PhD Coursework plus thesis track: PhD-Type 2.1*).
6. Thesis result must be published or at least accepted to publish in a journal, media, printed matter, or registered a petty patent or patent, or in other forms accepted by the field of study with the approval of the graduate school for each level and/or type of study.
7. Having qualifications complying with the university regulation on student's honor and glory determination to graduate a degree or diploma of the university.
8. Being honest and faithful with morality and ethics, by righteously and legally creation of work based on facts without any biasing, making up or false data, violating rights, stealing, copying, imitating or repeating (plagiarizing) works of the others.

## FINANCIAL INFORMATION AND SCHOLARSHIPS

CMU School of Public Policy was established as an internal academic institute of Chiang Mai University, according to the University Announcement title ‘the Establishment of Internal Academic Unit of Chiang Mai University B.E. 2560’ dated 11 September 2017.

### **Tuition Fee:**

For both domestic and international students, the program costs 480,000 Baht for 3-year thesis-only track (160,000 Baht/academic year or 80,000 Baht per semester). Or 720,000 Baht for the 4-year thesis and coursework track (240,000 Baht/academic year or 120,000 Baht per semester). The payment of tuition fee is calculated and payable based on a 3-year program track for both types of curriculum. Should the student be seeking extension of their enrollment beyond 3 year period, they are required to pay small annual general administration fee to maintain student status. Student is required to complete a PhD program within 5 years of his/her first year enrollment.

The tables below provide the breakdown of program costs and living expenses: tuition fee payable per semester, living expenses as per month. We also provide the estimate of a total cost of program for 3-year enrollment. These estimates were derived from Chiang Mai University Presidential Scholarship scheme, which provide information about allowances for Doctoral Level ranging from Tuition and Fees, Insurance, Living, transportation and accommodation allowances, Air ticket from/to home country and CMU.

#### Health Insurance:

CMU requires that every international student residing in Thailand to purchase a health insurance covering the whole period of their studies, if they haven't got one already. SPP staffs, we will assist you find a good value package of health insurance. The package that we will offer to SPP students require you to pay the annual premium based on student's age.

**Student will be responsible for paying the costs of the following items**

1. Financial resources for living expenses, based on your personal needs. Please also refer to the breakdown of expected costs ([Read https://www.numbeo.com/cost-of-living/in/Chiang-Mai](https://www.numbeo.com/cost-of-living/in/Chiang-Mai)), and details of in-campus and off-campus accommodation in the next section of this Handbook.
2. All your travel-related costs (and visa) and expenses incurred before your arrival at SPP.
3. Student Enrollment Fee, as of academic year 2020, it is included in the Tuition Fee. The Student Enrollment Fee covers institutional costs related to: maintaining the student status in the university's database systems, reporting required by Thai law, information technology services and financial services. The Fee entitles students to use computer labs, email and Internet access, and contributes to university residential life programs, student activities, and the activities of the Student Union.
4. Application Fee is incurred for those who are accepted at the rate of 900 Baht per application.

**Scholarship Eligibility:**

Students may apply for financial supports from CMU and/or SPP within the deadlines.

**1. CMU Presidential Scholarship (Two round of application, Announce end of April 2020):**

You may be eligible to apply for the [CMU Presidential Scholarship](#). The scholarship requires excellent academic performance as demonstrated by a minimum of 3.50 GPA of 4.00 grading system in the Master degree level and the submission of Certificate of English Language Proficiency, TOEFL or IELTS only. (IELTS scores of 6.0 or equivalent, TOEFL scores of 550 (paper-based) or 183 (computer-based) or 79 (internet-based). Details of funding is provided in the attachment. Upon successful application; you will be informed of the result by the CMU Selection Committee by end of April. SPP will contact you, should there be any request for more documentation.

In some cases; SPP may assist with basic student registration on their behalf. Student can review and/or submit any other required documents to the Chiang Mai University Graduate School database via

It is important that student supply all the required documents in order to complete the selection procedure. Failure to do so will be result in the withdrawal of the application for CMU scholarship. Required documents include;

- a. Academic Transcript (Bachelor's Degree)
- b. Academic Transcript (Master's Degree)
- c. Research Plan. Give a description about 3-5 page long, explaining the subject of research plans at Chiang Mai University. The Scholarship is intended for original and publishable research (not for the compilation of textbooks or the writing of general surveys of your field).
- d. Certificate of English Language Proficiency: IELTS or TOEFL only. IELTS scores of 6.0 or equivalent, TOEFL scores of 550 (paper-based) or 183 (computer-based) or 79 (internet-based).
- e. Two recommendation letters, one of which must be from the applicant's direct supervisor and another one should be from the person most familiar with his/her scholarly work.
- f. Journal / Publication (1)
- g. Journal / Publication (2)
- h. Journal / Publication (3)

**2. CMU TA/RA Grants (Deadline 30 April 2020, Announce May 2020):**

Chiang Mai University provides TA/RA grant amount of up to 108,000 Baht per year, payable at 9,000 Baht per month, of up to three years for the enrolled graduate student.

In the application process, there will be both CMU Presidential Scholarship and Teaching Assistant/Research Assistant. The applicant will be able to apply for either one or both types of the scholarships, but will be granted the eligibility to receive only one type of the scholarship. **3. CMU-SPP TA/RA Scholarship (Application same period of CMU-SPP admission consideration):**

Given your outstanding academic performance and relevant research topic; you are eligible for the Chiang Mai University School of Public Policy TA/RA Grant administered by CMU-SPP. The scholarship covers partial tuition fee for the Master and PhD students.

(The Journal must be accepted by the Graduate College as shown in the database.)

**STUDENTS HOUSING**

Chiang Mai University housing service functions as educational dormitory for Learning, Living and Caring Center. Services are provided to the residency of colleges as well as those coming to use the facility as center of learning. There are various programs and activities which support career development of the students. Including academic tutor, foreign languages tutor, personality training, and specific career training. There are a lot of activities provided by the university housing services; the reading rooms, the computer rooms, the library, and the activities rooms which give the chance for students to get together. For example, the merit dormitory's activity, the dormitory room contention and volunteer activity. Moreover, the environment around dormitory is clean, beautiful, sylvan, and safe.

The University Dormitory Office operates a total of 19 dormitories consisting of six male dormitories, eleven female dormitories and a mix-gender dormitory, organized in two separate sections.

**Conditions for Application to Student Dormitories:**

- Application can be made according to the process flow available via website <http://udo.oop.cmu.ac.th>
- Applicants are required to log-in with their student ID, (TCAS) used for Entrance Examination, to make reservation in the CMU system. Complete application has to be printed out and submitted to the University Dormitory Office during the July month.
- Students can apply for one dormitory building only.
- Information provided in the application form must be valid and complete.
- Students who enroll under the youth development programs for promoting excellence in sport have to apply for either Male Dormitory building 4 (4th floor) or Female Dormitory building 6 (4th floor).
- Motorcycles and cars are not allowed for use or store in the dormitories. Any violation will result in application being disqualified.

The [CMU network of dormitories outside](#) the campus is available to CMU students who are not qualified under the above application system. Monthly rental rate is ranging from THB3,500 - THB6,200 for single or double occupancies.

**FOR CMU-SPP @MAE HIA CAMPUS**

Students who are not enrolled under the CMU student enrollment system, or other staff and academic members, may seek private housing available elsewhere around the campuses and Chiang Mai city, Suthep sub-district. Generally the off-campus housing apartments are furnished with basic furniture: bed & mattress, hot water, refrigerator, fan (some with air-con), TV, working table, chair and a wardrobe. Some may include a small kitchen. Off-campus housing/apartments offer higher rate (THB5,000 - THB12,000 monthly) with convenient locations and/or more luxurious furniture. The rent amount usually does not include utility costs or WIFI. Residents have to seek their own laundry services outside the resident by paying monthly fee, or per piece or laundry machines.
